### 2.1 Roles

There are two different actors with in eFa with different tasks. The following roles in the system will reflect the daily work of the actors. Therefor they are only allowed to work on certain modules.

The table in the following sections will give an overview of the roles permissions on the different modules. *x* means is allowed, *o* means is not allowed. On modules which are not listed here, the does not have any permissions.

**Note:** The permissions of the different roles do not reflect which modules are shown in the header menu of the UI. So a user who is basically allowed to read or list items of a module must not necessarily see the module entry in the header menu.


The organisation accompany the participants and document their work in the electronic files.


